- Secretary's Report
 - Final 2019 Memberships: 161
 - o 2020 Memberships as of annual meeting: 56
- BOD Meeting
 - Need new volunteers to haul the trailer
 - Looking at the possibility of a second trailer that can be used for Brothers-Only gear
 - Looking at custom flatbeds
 - Security is an issue

 - We have discussed co-branding a launch.
 - They are encouraging members to attend our launches, especially May.

 - 22% MPR
 - 41% HPR
 - Rocketober this year: 288 (third biggest launch this year)
 - o HIGHLIGHTS
 - Another safe launch season
 - No cancelled launches
 - Sparkies at NXRS (low fire danger year)
 - Lots of help at LCO/RSO when it was needed
 - Finally have a decent sound system setup
 - July launch presented a new interference issue between FM and the wireless launch controller
 - Lots of new members!
 - Tri-cities launch went really well!
 - o LOWLIGHTS
 - Someone built a hanger and airstrip next to our property (East North East of our pads). Hopefully this won't become an issue. Still waiting to hear back from property owners.
 - Property fees were raised by landowner for the Southern area of the launch site

 - We lost the AED for basically the whole season. It has been found.
