Yes - change bylaws to add an Equipment Director receives 78 votes, 93.98% of the total. Abstain receives 3 votes, 3.61% of the total.


No - do not change bylaws to add position receives 2 votes, 2.41% of the total.


Bylaws Amendment: Re-word Promotions Director description
